DEADLINE FOR PRIORITY PROCESSING: March 26, 2010

- Carefully read and complete the entire application. An incomplete application may cause a delay in processing your request.
To receive financial aid for the summer 2010 term you must have a completed file in the PTC Financial Aid Office. A completed file includes a valid 2009-2010 Federal Aid Application, data form, and verification documents, if required.
The Federal Pell Grant regulations have changed. All Pell Grant recipients who did not attend full-time Fall 09 and/or Spring 10 may have remaining funds for use in summer. In addition, Pell Grant funding may now be available to those who did attend full time Fall 09 and Spring 10 and have already received their annual Pell award. Additional information and requirements will be enclosed with your award letter if you are offered a summer Pell Grant award.
To be eligible for a student loan, you must enroll in at least a total of 6 hours for the summer. If you enroll in 3 hours for summer I, you must be pre-registered for at least 3 hours for summer II.
ALL transcripts from other institutions must be evaluated before you can receive any financial aid awards.
