Pulaski Technical College Foundation raised more than \$6 million through private, corporate and government grants in 2010. Funds were invested in scholarships, the Business Technology Center, student achievement activities and education, and training related to green jobs. Substantial grants are being invested to create a Weatherization Training Center, a Building Training Center of Excellence and a mobile lab to train Arkansas residents in green jobs in weatherization and energy.

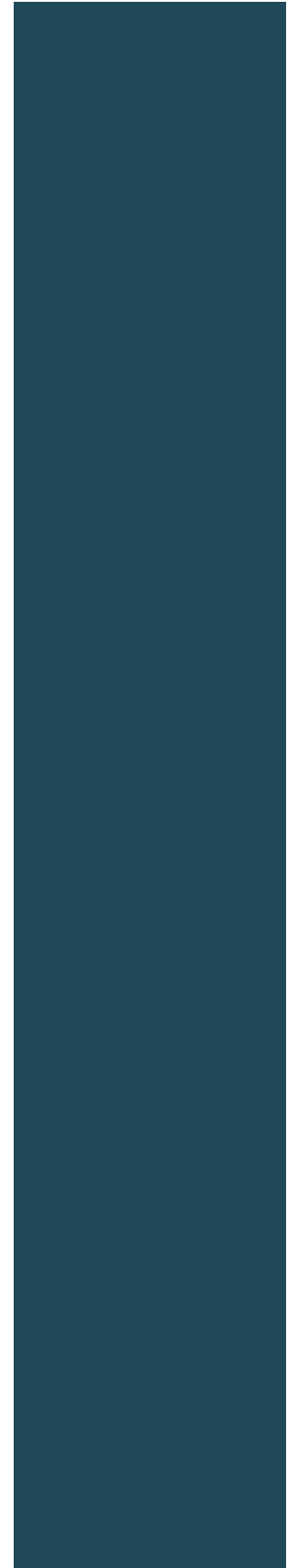

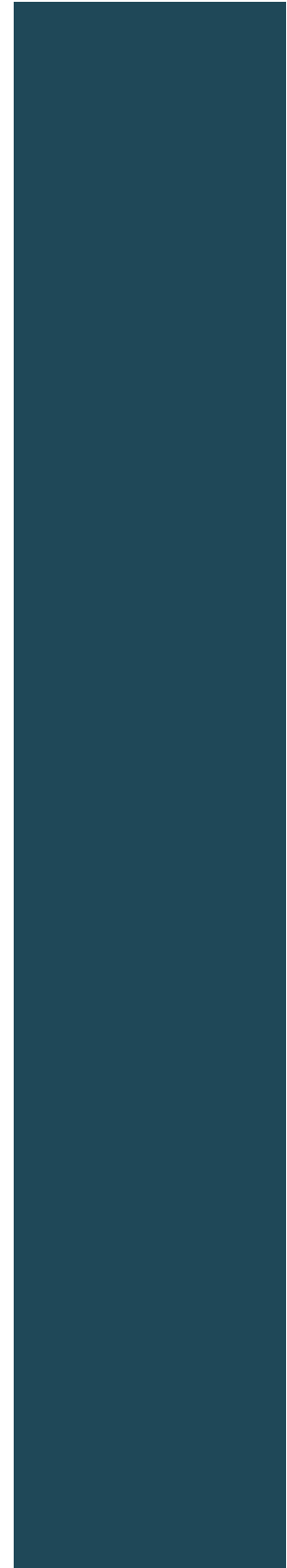

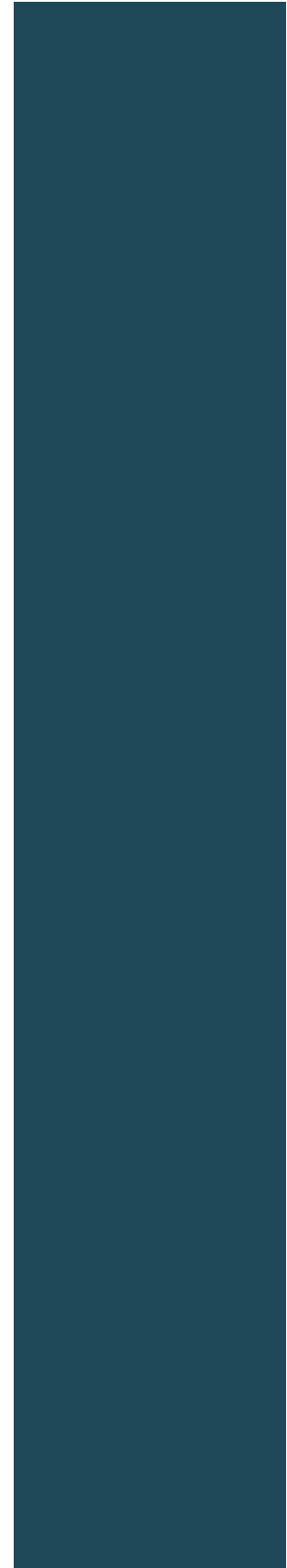
